GENERAL INFORMATION

- 1. Only online applications which are duly filled at our website (https://appskandla.iffco.coop/KD_Apprentice) will be accepted. Applications submitted in any other form will not be entertained.
- 2. Candidates presently undergoing or who have already completed Apprenticeship elsewhere shall not be eligible.
- Candidates seeking reservation under SC/ST/OBC categories are required to bring SC/ST/OBC (Non-Creamy Layer)
 certificates issued by GOI (Govt. of India) failing which they will be treated at par with other candidates of unreserved
 category.
- 4. Uploading of every marksheet (all semester/annual) and certificate are mandatory, failing which your application will be rejected.
- 5. If at any stage of the selection process, including joining, any of the documents such as marksheets, certificates, caste certificate of applicant is found incorrect/false will be liable for termination of his apprenticeship training forthwith.
- 6. Engagement of apprentices shall be through Computer Based Test followed by Interview and Medical Fitness Test.
- 7. Details of Computer Based Test will be informed separately through SMS/e-Mail on Mobile Number/e-Mail ID provided by applicant.
- 8. **Stipend**: As per the latest Apprentices Amendment Rules.

- 10. Selected candidates will be required to enter into a contract of Apprenticeship with IFFCO as required under the Apprentice Act, 1961.
